- 5. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or **before** 12:00 Noon on 17th April,2022. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hours on 17th April,2022 at the Chumnubri Rural Municipality, Office of the Rural Municipal Executive, Sirdibas, Gorkha, Gandaki Province, Nepal. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security, amounting to a minimum mention above, which shall be valid for 30 days beyond the validity period of the bid. Bidders shall deposit the bid security at the above bank mentioned or as bank guarantee in standard format as specified in bidding document from "A" class commercial bank specifying the contract.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
