5. The bidders are informed to attach supporting documents to verify the Qualification Criteria.

The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 hours of 2078/01/19 (02nd May 2021)**, at the office of **Chumnuhari Rural Municipality, Office of Municipal Executive, Sirdibas, Gorkha**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs: **204,000.00**. Which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
